Applications are invited for the position of **Information Scientist 'B' (Project)** under the **Dementia Science Programme (Data Storage Facility)** funded by DBT and coordinated by Director I/C, National Brain Research Centre, Manesar, Haryana. Minimum qualification:

1. **M. Tech. in Computer Science or MCA (Computer Science) / IT with 1 year of experience or B. Tech. / B.E. with 2 years of experience from a recognized University / Institute. Preference will be given to M. Tech. in computer science.**
2. **Strong academic record - matriculation onwards with minimum of 60% marks.**

Desirable experience:

- 1-year experience in managing high-throughput storage systems (NAS/SAN) of 200TB or more, preferably hands on experience on DELL-EMC Isilon storage.
- Network administration (CISCO/DELL managed switches).
- Good working experience in Linux OS, web programming, software development.

Age limit: 35 years on the closing date of application (**24th November, 2021**)

Duties: The selected candidate will be required to manage the central storage server and backups, and conduct performance monitoring and optimization. In addition to other relevant duties assigned from time to time by Project Coordinator/Principal Investigator, s/he will coordinate with stakeholders from other institutes for synchronization of data and will develop applications for management of data coming from multiple sites.

Emoluments: ₹ 50,000/- per month (consolidated). No other allowances / benefits will be admissible.

Mode and duration of appointment: Appointment will be made on contract basis, initially up to **17th December, 2021** or the duration of the project, whichever is earlier. **The tenure may be extended depending on the project extension.** Continuation of appointment will depend upon satisfactory performance during the appointment period and validity of the project. The post is co-terminus with the project.
