2. Minimum educational qualification:

First class Diploma in Engineering (full time course) in the respective discipline with 60% marks from state Board of Technical Education/recognized Indian University (relaxed to 50% for SC/ST candidates). The institution shall be located only in the state of Madhya Pradesh and the course shall have AICTE affiliation.

3. Age: 18-24 years as on 1st January 2022 for general/unreserved candidates (DOB between 01.01.1998 to 01.01.2004). Relaxation up to 5 years for SC/ST candidates and 3 years for OBC (NCL) candidates shall be provided

4. Reservation of vacancies: Guidelines under the Apprenticeship Act on the reservation for SC/ST/OBC will be followed. Those who are claiming reservation under SC/ST/OBC shall provide certificate as per the standard format prescribed by the Government, failing which their claim for reservation will be considered as "General" category only. Candidates claiming reservation under OBC category should bring OBC certificate (non-creamy layer) as per Govt. prescribed format from the certificate issuing authority of Tehsildar. Applicable certificates (in original) need to be produced at the time of interview.

5. Duration of Training: The duration of apprenticeship training will be for a period of one year

6. Previous training experience: Candidates who have already undergone or are currently undergoing apprenticeship under the apprenticeship (amendment) Act 1973, and/or having one year of experience are not eligible to apply

7. Selection procedure: Selection will be based on marks obtained in the qualifying exam and interview. The final merit list would be prepared according to categories General/SC/ST/OBC on the basis of mark obtained by the candidates. Engagement for Apprenticeship training will be Subject to the selected candidates clearing the medical examination.

Only those candidates will be considered for the apprentice engagement who have completed their Diploma from colleges based in Madhya Pradesh.

11. Candidates should have taken double dose of vaccine at the time of appearing for interview or medical examination. Candidates must carry covid 19 vaccination certificate issued by Ministry of Health and Family Welfare, Govt. of India. Interviews will be held physically or online mode will be informed to shortlisted candidates by email and telephone.
