Name of the Post: Executive Trainee - Finance (CA/CMA)

Qualification: CA/CMA qualified from institute recognized by appropriate statutory authority in India, are eligible to apply.

Age Limit: Maximum 34 years as on last date of online application.

COMPENSATION PACKAGE:

Selected candidates will be placed in the pay scale of Rs.40,000-1,40,000 at the basic pay of Rs. 40,000/- (E1 Grade). The other benefits such as Dearness Allowance, other perguisites and allowances, terminal benefits, etc. will be admissible as per company rules in force from time to time during training / after absorption.

PLACEMENT:

The selected candidates shall undergo one-year training at various places. The final place of posting will be decided after completion of training. Candidates can be placed, across the country, in any of projects/ stations including Subsidiaries/JVs companies of NTPC.

HEALTH

The candidate should have sound health. Before joining, candidates will have to undergo medical examination at any of the NTPC hospitals and the decision will be final and binding. No relaxation in health standards is allowed. Detailed medical norms are available on the website careers.ntpc.co.in

GENERAL CONDITIONS:

- Only Indian Nationals are eligible to apply.
- All qualifications should be from Universities / Institutions recognized and approved in India.
- Computations of age and qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement. The date of declaration of result / issuance of marksheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account.
- Candidates shall necessarily have a valid ST certificate from the Competent Authority. Relaxation of age to PwBD/Ex-Serviceman as per Govt. guidelines. 5 vears age relaxation for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01.01.80 to 31.12.89.
