The candidates fulfilling the requirements must bring all the original documents on the interview day alongwith duly filled the biodata for verification. <b>Nature &amp; Duration of post</b>	:	The post is purely on a contract basis for one year (as per ICAR guidelines).
<b>Emoluments</b>	:	Rs. 15,000/- per month consolidated as per ICAR guidelines).

## General terms & conditions:-

1. The applicant must bring all the original documents and the biota for verification during the interview. Candidates should produce one valid ID proof at the time of the interview.
2. Interview of eligible candidates for the above contractual position will be held at the Committee Hall, ICAR-Tuticorin Regional Station of CMFRI, Thoothukudi-1.
3. Only passed-out candidates are eligible to apply. Candidates awaiting the result are not qualified and need not apply.
4. The crucial date for determining the age limit shall be the interview date.
5. For SC/ST candidates, an age relaxation of 5 years and three years for OBC candidates will be given as per the Govt. of India/ICAR rules.
6. The above position is purely temporary. The appointment will be a co-terminus with the termination of the project. Other terms and conditions will be per the revised ICAR guidelines for recruiting Young Professional & Field Assistant in ICAR.
7. The selected candidate will have no right whatsoever for absorption/regularization in the institute.
8. The selection of candidates does not entail any right for absorption/ regularization at CMFRI.
9. Every candidate has to wear a facemask and follow COVID-19 protocol.
10. The service of the selected candidate can be dispensed with even before the termination of the project without any notice if his/her service is no more required or his/her contribution is considered not up to the mark.
