- 3. The crucial date for reckoning the age limit and essential qualification is the last date of receipt of application. However, age relaxation will be applicable as per Government instructions:-
- (a) 03 years for the candidates belonging to OBC,
- (b) 05 years for the candidates belonging to SC/ST category,
- (c) 10 years for the candidates belonging to Physically Handicapped. (Additional 05 years in case of Physically Handicapped belonging to SC, ST and 03 years for OBC category).
- (d) Ex-servicemen: Ex-servicemen who have rendered not less than 06 months of continuous service after attestation in the Armed Forces shall be allowed to deduct the full period of such service from their actual age and if the resultant age does not exceed the prescribed maximum age by more than three years, they shall be deemed to be within age limits.
- (e) Central Government Civilian Employees who have rendered not less than 3 years of regular and continuous service as on closing date of receipt of online application upto 40 years of age and upto 45 years of age for SC/ST.
- (f) Widows/Divorced Women/Women judicially separated and who are not remarried upto 35 years of age and upto 40 years of aged for SC/ST.

## 4. Mode of Selection:

- (a) Selection will be made on the basis of competitive examination which will consist of two parts:-
  - (i) Written Examination of 100 marks.
  - (ii) Typing test/shorthand test/trade test wherever applicable to the post & will be of qualifying nature.
- (b) The written test will consist of multiple choice questions of
  - (i) General Intelligence and Reasoning
  - (ii) Numerical Aptitude
  - (iii) General English
  - (Iv) General Awareness
- (c) Written examination will be of two (02) hours duration. The standard of written test will be based on the minimum educational qualification prescribed for the post.

  The questions will be in English and Hindi language only.
- (d) Candidates, who qualify the written examination, will be called for trade specific tests as applicable to the post applied for (where required). The number of candidates to be called for trade specific tests will be five to seven times the number of vacancies.
- 5. General Instructions:-
- (a) Selected candidate will be subject to All India Service liability.
- (b) Merely fulfilling the basic selection criteria does not automatically entitle a person to be called for written test / trade specific tests.
- (c) Candidates are to bring original certificates viz. SC/ST/OBC/EWS/PwBD/ESM,

educational qualification / technical qualification and experience partificates at the time of the trade specific tests.

- (d) Incomplete application will be summarily rejected and no correspondence in this regard will be entertained.
- (e) No TA/DA will be paid for attending the written test/trade specific tests.
- (f) The written examination is tentatively scheduled to be held in the month of February / March 2025.
- In case the number of candidates is more and it is not possible to accommodated in the preferred choice of centre of examination then they will be accommodated in the nearest centre of examination. However, efforts will be made to accommodate those candidates who will be appearing for both 12th and 10th level of examination in the same centre of examination.
